Your signature below indicates that you have read, understand and agree to all of the following:

1. Parking at Douglas High School (DHS) is a privilege that can be revoked. Purchase of a parking pass does not guarantee a space, simply the right to park in the lot. When the lot is full the only appropriate place to park is on County Road.
2. Parking at DHS requires a pass to be visible hanging from the rear-view mirror of the car. **NO MATTER WHAT!**
3. Parking tags are issued to students, not cars, and can be moved from car to car as needed. Tags are not transferrable.
4. The speed limit at DHS is **TEN (10)** miles per hour.
5. Students are to park south of the school in the areas that have been designated for student parking. Students are not to park in posted handicapped parking (unless appropriate), **NO-PARKING ZONE** end caps, fire lanes, staff parking, or the bus lanes.
6. Our neighbors on Pinewood Drive continue to request that our students not park there. This area should be considered off limits.
7. Initial tags cost \$10. Students who purchased last year's tags (2016/17) can exchange them for a \$5.00 credit towards the \$10.00 cost of a 2017/18 parking permit when this form is signed by both the student and the parent/guardian. Verification of ownership of prior pass will be required as parking tags are **not transferrable** to other family members.
8. Tags will not be issued until this completed form is returned to the office with the fee.
9. Stolen tags need to be reported immediately. New tags may be available at the original price.
10. Parking tags are only being sold to Juniors and Seniors through September 8th. Sophomores, and their parents, who wish to purchase a tag are being asked to complete the back of this sheet. Due to the limited number of passes available, Freshmen will not be allowed to park on campus.

The Consequences for violating the above:

FIRST offense	\$10.00 fine	SUBSEQUENT offenses Car towed at owner's expense and consideration for permanent ban from parking at DHS.
SECOND offense	\$25.00 fine	
THIRD offense	\$50.00 fine	

The parties signing below understand that the parking lot is public property that is under the control of the school. Students understand that they will prominently display the parking permit on the vehicle. The Student also agrees that the authorized vehicle will not be used to transport or store contraband of any kind (including, but not limited to, guns, knives, controlled substances, or alcohol) or use the lot in any way that will violate the school district code of conduct or criminal law (school board policy 529A and NRS 392.466).

The Student also provides DHS with consent to search the vehicle when it is parked on school property. The contents of the car are in the possession of the driver of the car and subject to applicable laws and school board policies.

The parking policy will be enforced beginning on **MONDAY, AUGUST 28, 2017.**
